Z-HOPE for Women – Spirit Meeting the Basic Needs - For Those Spiritually Challenged

Objectives:

- To provide items to battered women and their children
- To improve self esteem as basic needs are met

Overview

Domestic violence is a far larger problem than most people realize. Around the world, at least one in every three women has been beaten, coerced into sex or otherwise abused during her lifetime. (Heise, L., Ellsberg, M. and Gottemoeller, M. Ending Violence Against Women)

Procedure:

Each chapter/auxiliary will donate **one set** from the six sets listed below:

1. Paper Products – 20 rolls of paper towels, 10 4-pks of toilet tissue, and 10 boxes of trash bags
2. Paper Products – 10 packs of plastic forks, 10 packs of plastic spoons, 10 packs of paper plates, and 10 packs of paper cups
3. Emergency care items – 20 used cell phones
4. Personal care items - 20 packs of tampons or maxi pads
5. Personal care items – 20 washcloths and 20 large bath towels
6. Cleaning items – 10 containers of laundry detergent
7. \$50 – please make checks or money orders payable to the **SC State Chapters**

*Bonus points will be applied to the Women Population in the selected dimension
(Mind, Body, or Spirit).*
